Hello, Friends!



for YOUTH by YOUTH

The for Youth by Youth (FYBY) Coalition is a new coalition backed by Coos Health & Wellness, Kairos, and Oregon Youth MOVE, as well as volunteers representing 12 societal sectors. This coalition formed in April to address substance abuse and other health issues experienced by youth in our community. Efforts at a drug free community in Coos County have been happening over many years, but the approach of this newly formed coalition is different. Past efforts have been adult centered, including youth. This time it is youth centered, including adults. This coalition is youth driven!

What that means is that the youth are the decision makers, and they are directing the course the coalition is going. These young people have the support and available guidance of adult mentors. These adults have pledged to take a step out of the usual adult directive role and are excited to see youth leadership emerge. It is the belief within the coalition that youth know best what is happening and needed with their peers, as youth see it every day—in schools, on the streets or in their homes. FYBY's mission is to Help Empower Youth to Create a Brighter Future. FYBY is in its six month since inception and already has had some exciting things going on to fulfill their mission:

Coos Empowered Picnic: In June, a fun day to engage and recruit more youth.

Youth Suicide Prevention Focus Group: In September, a focus group for the State Youth Suicide Prevention Program.

Youth Leadership Training: In September, hosted a kick off informational session about an upcoming Youth Leadership Training that will be facilitated by Oregon Youth M.O.V.E. Eighteen youth

attended the kick off session and nine youth signed up to attend the trainings. The trainees meet twice a month for two hours and cover topics such as Youth as Policy Partners, Advocacy 101, and Leadership 101.

Bowling for Recovery: In September, for community awareness about alcoholism and drug addiction and to celebrate National Recovery Month.

SW Oregon Opioid Summit: In October, FYBY presented information about Prescription Drug Abuse and Heroin: Regional and Statewide Impact on Youth and Young Adults.



Over the next six months the coalition will continue leadership training and focus on completing a community assessment, developing a five year work plan, outreach and recruitment in schools and furnishing the FYBY headquarters. Blue Zones for Coos County? — An Update by Florence Pourtal-Stevens

Some of you have been asking to get some updates regarding our Blue Zones application. As you may remember, the Healthy Eating Active Living (HEAL) subcommittee of the Community Health Improvement Plan (CHIP) applied on behalf of the cities of Coos Bay, North Bend and Coquille to be considered to become the second Blue Zones demonstration community in Oregon.

The application was due at the end of August 2016. At the end of September, the Blue Zones state team informed us that we had been selected – along with six other communities in the State – to move along in the process and get a site visit from various representatives of the Blue Zones team. Our site visit was a way for the Blue Zones team to get to know us better and to assess our community health outcomes, strengths and challenges and get a sense of our community readiness to implement the Blue Zones project. Some of the requirements of the visit were that we had to build a robust presentation about our community featuring who we are, some of our history and context, our strengths, challenges, and opportunities for a Blue Zones project, and also some of the work we have accomplished as a community. We also had to show that we are ready for this project and invited key stakeholders from each three communities in the various sectors that Blue Zones works with, e.g. governments and policy makers, restaurants and grocery stores, work sites, schools, faith based organizations, civic organizations and the media, to be part of the site visit. Also, if people were unable to make our meeting they had to sign a document pledging their support to the project if we were to be selected.

Well, what we can say is that we did everything we could to make a strong case for our communities! We had a tremendous show of people: approximately 80 people came and participated in the event held at OCCI on October 10th 2016. When the Blue Zones team asked people if we were missing anyone, the response was clear: "No, everyone you would need is either here or has signed the pledge"! Since the visit, we have been waiting to hear back from the Blue Zones team. They delayed their announcement to December 2016. So as soon as we know we will be sure to let you all know of their decision!



Thanks again for your support and continued interest in this project and in making our community a healthier place to live, learn, work and play!
