Coos County Public Health Annual Report - 2010/2011

The Coos County Public Health annual report for fiscal year 2010/2011 has been published. You can read about the health issues in the county, as well as learn more about the services provided by the Health Department. For example: Coos has a lower teen pregnancy rate than the state-wide average; food vouchers worth \$1.12 million were provided to WIC participants in a year's time; and 287 temporary food service licenses were issued for food booths and other special food events. Floods & Contaminated Wells

After a January deluge of rain, and flooding along the Millicoma River, at least one public water system was left with a well under 2 feet of water and certain contamination. This small public water system had 10 homes obtaining water from the same well - a total of about 25 residents. This is the typical size of the public water systems that Coos County's Environmental Health staff work with routinely. The Oregon Public Health Drinking Water Program contracts with Coos County Public Health to work directly with 59 of the 79 public water systems known in Coos County. The larger water systems, such as the Coos Bay North Bend Water Board, have direct oversight from the state. What defines a public water system? It's a well that provides service for at least 60 days per year to at least 4 residential connections or to 10 people or more.

Many of the smaller public water systems are operated by volunteers. Environmental health personnel spend significant amounts of time helping these water system operators understand the regulations which help to assure their water is safe to drink. Having a relevant written emergency response plan that tells what to do if the well is contaminated or flooded is an indicator of a properly run water system.

The "private" water systems, such as a well for a single residence, receive no oversight from Public Health. In the last 10 years, there have been numerous cases of enteric (gastro-intestinal) illnesses where the source of illness was never identified, and where the patients used home water of unknown quality. Sometimes these residents were unaware that their water came from a well, which had not been tested in years. If they call the Environmental Health Office, (541-756-2020, ext. 643) they can be referred to resources, such as the Oregon Drinking Water website, for advice.

CCFoPH 2012 Annual Meeting

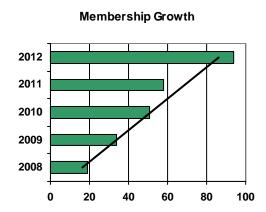

The number of Friends in attendance at the Annual Meeting, on a beautiful Friday afternoon, was wonderful. The luncheon provided opportunities to meet new Friends and reconnect with Friends known and treasured. However, the reports were the highlights of the event.

Angie Webster, our outgoing president, gave a concise review of the Friends activities over the past year. She focused on fundraising activities - Coins for Coos Kids (our ongoing fundraiser), Purses for Nurses (our big event these past two years), and the Wine Walk held in Coos Bay. In addition, Zonta Club and the Coquille Tribal Health Fund were recognized for their grant support for women's health services.

Debbie Webb followed with the Treasurer report and it was noted by members present that our overall projected budget has increased from last year by almost 50%, based on fundraising, membership dues, grants and support from our many Friends.

Connie Bunnell, our Membership Chair, told us that our membership is 108 individuals, which represents 94 memberships (some include family), up 30% from last year.



Frances Smith gave her update on the public health department. She had good news about the variety of services available to help us stay healthy in Coos County; and sad news about statistics on early deaths, tobacco use, obesity and lifestyle issues that affect many Coos county residents. Child abuse and neglect continue to be significant issues, as do the struggles single parents have in managing family needs on low incomes. Bright lights on this rather dismal picture were the health department's efforts to bring residents together last spring in forums and a final summit session to talk about how to improve the health of those living in Coos County. A follow up to the summit was the recent January Worksite Wellness event that engaged more than 70 people in talking about how to improve our overall health in the county.

New board members were nominated and elected, and our good Friends Angie Webster, Chris Flammang and Stephen Brown were recognized for their outstanding leadership on the board this past year, as they move on to other activities. It is hoped that we will see them frequently as part of Friends activities in the future, even though their board service has been completed.

Reminders were also made to attend the upcoming Membership Social event at Cicarelli's on February 16, from 6:00 - 8:00 p.m... and to bring a friend to learn more about our amazing Coos County Friends of Public Health, and its purpose to support our much needed public health programs.

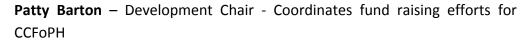

Worksite Wellness – It Can Be Done!

Promoting health at work can be as simple as removing the candy dish from the receptionist's desk, and providing water instead of soda pop at office parties. Many other "doable" suggestions were discussed on January 25th at the *A Healthier Coos County: Worksite Wellness Action Forum*. This was the second annual forum presented by the Healthy Communities program of Coos County Public Health.

After a welcome from Coos County Commissioner, Cam Parry, participants walked through a Gallery Guide describing the health statistics relevant to our county's workforce. Then panelists from the Mill Casino, Bureau of Land Management, and Sause Bros. described their current wellness programs. They answered questions about employee health assessments, the incentives for their staff to participate in healthy activities, and lessons learned that would be helpful to others. Each panelist had a wealth of information to provide, which gave the audience numerous ideas of what they could implement at their own worksites. The featured guest speaker, Dawn Robbins, was from the Oregon Health Authority, where she leads the Wellness@Work Initiative. She described how to create a culture of health at the worksite, and also included a guided tour of a web-based tool for developing and expanding worksite wellness programs (www.healthoregon.org/wellnessatwork). The forum ended with time designated for each business/agency to develop an action plan that included goals and next steps for wellness at their worksite.

The event was deemed a success with over 70 participants and representation from over 35 agencies and businesses. The clear message was that worksites in Coos County can support and encourage employees to live happier, healthier, and more productive lives.
